NOTICE CONCERNING POSSESSION OR PURCHASE OF FIREARMS

Pursuant to Ohio revised Code Section 2943.033, you are advised that if you enter a guilty plea or plea of no consent to a misdemeanor crime involving violence where you are or were; A spouse, person living as a spouse, former spouse of the alleged victim; A parent or child of the alleged victim; A parent or child of a spouse, person living as a spouse, or former spouse of the alleged victim; or The natural parent of any child whom the alleged victim is the other natural parent or the putative natural parent, it may be unlawful for you to ship, transport, purchase, or possess a firearm or ammunition as a result of any conviction for a misdemeanor offense of violence pursuant to federal law under 18 U.S.C. section 922 (g)(9). If you are convicted of a misdemeanor crime involving violence where you are or were a spouse, intimate partner, parent, or guardian of the victim or are or were involved in another, similar relationship with the victim, it may be unlawful for you to possess or purchase a firearm, including a rifle, pistol or revolver, or ammunition, pursuant to federal law under 18 U.S.C. 922 (g)(9) and/or state law.

If you have any questions whether this law makes it illegal for you to ship, transport, purchase, or possess a firearm or ammunition, you should consult an attorney.
